Emergency Solutions Grant Input Session/Focus Group – Jessica Isquierdo, Oklahoma Dept. of Commerce conducted an input session for the Emergency Solutions Grant.

- 1. CoC Meeting Introductions: Everyone in attendance introduced themselves and the agency they represent. Please see attached sign in sheet.
- 2. Projects for Assistance in Transition from Homelessness (PATH) Update
 - a. CREOKS-Stacey Williams; We serve Pittsburg, Latimer, Atoka and Coal Counties. Our client numbers are at an all-time high right now. Referrals can be made to our offices by the client themselves, please keep in mind if they have an open prior authorization from another mental health provider we cannot help them. We have several outreach events coming up that we will be attending. Also, we have a case manager job opening if anyone is interested.
- 3. Supportive Services for Veteran Families Program Update
 - a. Community Service Council-no representation.
 - b. KI BOIS CAF- Tammy Randazzo; We have funding available and taking referrals. Referrals can be made through 211, or by an agency, you can complete our referral form and return it by email. If you complete the referral form we then can provide you with a follow-up regarding the veteran. We have funds for rental and utility assistance, housing supplies and various other things to assist our veterans who qualify.
- 4. Homeless Management Information System (HMIS) There is a new contact Olga with be starting July 1st a contact email is HMIS@CDSAOK.org. Each agency should have a contract and be retained by June 30th.
- 5. 2023 Point in Time Count/HIC-see the meeting packet for numbers submitted in the HUD HDX.
- 6. 2022 System Performance Measures; see the meeting packet for submitted reports. Stella M was reveiwed.
- 7. 2022 Longitudinal Systems Analysis (LSA) formerly the AHAR; was submitted and accepted.
- 8. 2022 Competition Debriefing; see the meeting packet for scores. Two applications were funded: KI BOIS CAF Renewal PH-RRH \$123,567, The Grace Center DV Bonus \$\$78,274.

- 9. 2022 Special NOFO Debriefing; see the meeting packet for scores. One rural application was funded. This was the only project funded in Oklahoma.
- 10. 2023 HUD CoC NOFO has not been released yet but the registration has been approved.
