We are celebrating a new Federal Holiday this month! Juneteenth!

Juneteenth (officially Juneteenth National Independence Day, and also known as, Jubilee Day, Emancipation Day, Freedom Day, and Black Independence Day) is a now a federal holiday in the United States commemorating emancipation of enslaved African

Americans. It is also often observed for celebrating African-American culture. Originating in Galveston, Texas, it has been celebrated annually on June 19 in various parts of the United States since 1865. The day was recognized as a federal holiday on June 17, 2021, when President Joe Biden signed the Juneteenth National Independence Day Act into law. Juneteenth's commemoration is on the anniversary date of the June 19, 1865, announcement of General Order No. 3 by Union Army general Gordon Granger, proclaiming freedom for enslaved people in Texas, which was the last state of the Confederacy with institutional slavery.

June is also a month when many of our staff take their annual vacations. Unfortunately the large increase in gasoline prices, motels, airfare, and food have made vacations and travel very expensive.

The much higher cost of living is also making it more difficult for our low-income clients to survive. We are doing our best to assist them with the programs we have available!

Multisector Plan on Aging

"Our goal is to give every senior the confidence to live life on their terms and to provide them with the resources needed to lead a healthy lifestyle," said Buchanan.

By 2030, the population of older Oklahomans is



projected to increase by 21.3%, and for the first time in the known history of our state, seniors are expected to outnumber children. There are approximately 875,877 adults aged 60 and older in Oklahoma and approximately 140,000 adults aged 80 or older. This directly affects the folks we serve and KI BOIS will be involved with workshops such as this in the future.



KI BOIS Community Action has participated in the Volunteer Income Tax Assistance (VITA) Program for many years. Our team of IRS-Certified preparers were recently honored at their post-season recognition meeting on May 24th. Dena Baker, Tax Consultant with the IRS, presented appreciation certificates to the Site Coordinators and preparers to commemorate this successful season and partnership with the IRS.

Amy Fair, VITA Program Director, gave an update on the number of returns processed by each VITA location. Pittsburg County—269; Latimer County—142; LeFlore County—134; Haskell County—108 for a total of 653 Federal Returns. In addition, a total of 101 Oklahoma 538-S forms were submitted. The 538-S is a low-income sales tax refund for seniors.

The KI BOIS preparers and intake workers in each county were: Megan Reames, Debra Mikles and Lucille Johnson — Pittsburg County; Amy Fair and Stephanie McCann—Latimer County; Rosalind Newby and Jeremy Porter—LeFlore County; Christi Jones, Nikki Morrison and Royce Alverson—Haskell County.



KI BOIS Community Action is celebrating 55 years of operation. The month of May is Community Action Awareness Month, and the May 24th Lunch & Learn was dedicated to the history of our great agency. Two key players in the success of KI BOIS are Carroll Huggins and Claudia Jeffrey, both of whom have been here for the majority of those years.

Following a great lunch, Carroll, Claudia and other members of management shared stories and memories from the humble beginnings of Community Action up to the current status. KI BOIS is a leader in social services in Eastern Oklahoma. Beginning with single-county offices, it has grown to include a six-county service area... with some programs having an expanded service area.

As Carroll mentioned, "It's always a good day to be a KI BOIS employee!"



KI BOIS HISTORY 55 Years & Going Strong!

Soon after President Lyndon Johnson's declaration of war on poverty and of the Economic Opportunity Act of 1964, civic minded citizens of Easter began to prepare applications for federal funds to operate Community Act Programs. These applications were usually made in each county and most were funded. By the end of 1966 three of the four counties in the KI BOIS Co area were operating.

Haskell County's first director was Earl Jeffery. The director in LeFlore when Community Action began was Wallace Heatley who was soon rep Kirk. Latimer County, approved in 1966, hired Mr. Bill Beck as Direct 1967.

When Mr. Jeffery entered the Armed services in 1967, Jim Hall, Jr., was named director in Haskell County. By 1968 requirements concerning area population began to force smaller counties to consider the possibility of merging with neighboring counties, thus Haskell, Latimer, and LeFlore counties merged forming KI BOIS Community Action Foundation, Inc., which was incorporated on March 11, 1968 and appointing Jim Hall, Jr., as Executive Director a position he held until October 1978 when he retired. At the time of the merger E.A. Caldwell was working on an application for Pittsburg County which could be approved if this county became a part of KI BOIS Community Action. This was accomplished July 1, 1968 and KI BOIS Community Action became a four-county agency, encompassing Haskell, Latimer, LeFlore and Pittsburg counties. Muskogee, and Sequoyah counties were added later.

The first Board Chairman was Don Huddleston. Baysul Balentine, David Ward, Gene Bass, and John Cook served as Board Chairman for many years. Cecil Williams is our current Board Chairman. Upon the resignation of Mr. Hall, Carroll Huggins was hired as Executive Director in November, 1978. He is the current Executive Director/CEO and supervises 1,000 employees and oversees a 40 million dollar plus annual budget.

Among the earliest programs initiated by KI BOIS Community Action was Head Start, beginning while there were still single county agencies. By the summer of 1966, classes were starting and this program has grown to the extent that 1000+ children are enrolled in KI BOIS Community Action Head Start and Pre-K which was directed by Carolyn Jeffrey, Reba Dunn and Donna Carolan. Other early programs were U.S. Dept. of Labor Manpower programs which Earl Jeffrey directed upon his return from the armed forces.

Some more familiar names associated with the early days of Community Action in the KI BOIS Community Action arena are Marie Holley (later Morrison), Richard Baldwin, Reba Dunn, Joy Roye, Pauline King, Becky Hickman, Louise Searles, Jerry Barlow, Sharon Hickman, Faye Shoat, Barbara Walden, Brenda Daniels, Louise Gregory, Betty Nolen, Helen Scyrkels, E.A. Caldwell, Alene Williams, Phyllis Murphy and others too numerous to mention.
